# **Bush Fire Crisis**

Unfortunately, this fast pace has been matched by the distressing and raging fires we have all been exposed to in the media over the we start a new year the trials and tribulations facing those impacted by the recent bushfires are very much front of mind for the ADA.

A broadcast email from the Federal President ADA Inc. on 6 January 2020 reassured that the ADA is looking at ways to help those members, their practices and those away from the shocking impact communities directly affected.

At the time of writing this report, in early January, action plans were put in place at both a national level and also at a state level.

This ensured that each state managed their bushfire crisis and allowed for a structured and coordinated approach during such a difficult time.

The South Australian Branch ADA has taken measures to reach out to those members and communities that have been affected either directly or indirectly by the

devastating fires in our state. ADA SA took prompt action to email our membership and contact as many members whose communities were ravaged by fires to ensure Christmas and new year period. As that we could establish the number affected and full extent that these fires impacted.

> information compiled revealed that acknowledge all those who have there was very little direct impact on members and their practices in South Australia, unlike the eastern states. This however does not take it has had on the communities in those most affected areas such as the Adelaide Hill regions of Lobethal, Harrowgate, Cudlee Creek and Angle Vale, Fleurieu, Yorke and Eyre Peninsulas and Kangaroo Island.

Whilst the effect of these bushfires in these communities has been significant with regards to health and safety, there will clearly be long lasting emotional, economic and environmental implications and the full impact of these will only be determined in the next few months.

The ADASA is committed to

support and assist where possible. Should any members be aware of any colleagues or practices affected by these fires, please do not hesitate to contact the ADASA office.

The ADASA Branch expresses its heartfelt thoughts to everyone Fortunately, data collection and the affected by the bushfires and worked hard either professionally or in a volunteer capacity to respond to the fires and in the anticipated recovery process.

### **Parental Leave**

At the last Council meeting on the 9 December 2019, ADASA Council resolved to support the proposal to increase the subsidy for members in the Parental Leave category from 75% to100%.

The ADASA values its members and this is an opportunity to ease the financial burden for those members taking parental leave and maintaining the benefits of membership of the Association.

# **Mandatory Notifications**

Notifying AHPRA about a concern that a health practitioner may

be putting public safety at risk is called a 'notification'. Anyone is able to make a voluntary notification about a health practitioner but by law registered health practitioners, employers, and education providers must make a mandatory notification in some limited circumstances.

In early 2020, changes are being made to the requirements for mandatory notifications which are aimed at supporting health professionals to seek help about their health without fear of being reported.

These amendments have been made to allow dentists and other health practitioners to seek treatment for a range of health conditions with concern that mandatory notification may be triggered while still ensuring that the main aim of the notification system – protecting the public from harm - is maintained.

This edition of Dental Insights provides resources through AHPRA, and the National Boards including the Dental Board of Australia to help members understand the notification process.

# **SADS Meeting**

The discussions covered the issue of the National Partnership Agreement, and the impact on public waiting lists given the uncertainty of long term stable funding. Furthermore, ADA item numbers were raised as part of the various government schemes available (EDS GDS PDS) and it was confirmed that indexation of the schedule of fees for schemes

would be expected in April 2020 in alignment with Dental Veterans Affairs (unless DVA change or freeze updates).

Other matters of general discussion included the Rural and Remote Oral Health Coalition and the ADASA focus on the issues facing rural and remote dental practices as well dental care in Aged Care Facilities.

An ADASA opinion article formulated in response to this, was published in the Advertiser on Wednesday 22 January 2020, highlighting the management of 'Potential Preventative Hospital Admissions' of which chronic dental conditions is the third highest nationally and

the highest in South Australia (as noted in South Australian Oral Health Plan) and the importance of government funding. Such investment for at risk groups is vital so that they can have their oral health needs met at public clinics and Community Health Centres or through private practice and therefore, are not clogging up their local EDs with avoidable dental problems.

# Mandatory notifications: What you need to know

# Health practitioners encouraged to seek advice about their own health

An important part of being a health professional is getting the healthcare you need, without fearing a mandatory notification.

Mandatory notifications are a part of the National Law<sup>1</sup> and set out obligations for registered health practitioners, employers and education providers. These obligations aim to protect the public by ensuring that the Australian Health Practitioner Regulation Agency (Ahpra) and the National Boards are made aware of practitioners who may be placing the public at serious risk of harm.

Currently, registered health practitioners, including treating practitioners, and employers need to notify Ahpra if they reasonably believe another registered health practitioner has behaved in a way that constitutes 'notifiable conduct'. Notifiable concerns have a specific meaning under the National Law.

There are four concerns that may trigger a mandatory notification, depending on the risk of harm to the public:

- impairment
- intoxication while practising
- · significant departure from accepted professional standards, and
- · sexual misconduct.

Ahpra CEO Martin Fletcher said a health practitioner's physical or mental health issue rarely needs a mandatory notification.

'Having a health issue is not in itself a reason to make a mandatory notification. If a practitioner has taken steps to deal with it, such as taking time away from work, or are engaged in an effective treatment plan then we don't need to know about it,' Mr Fletcher said. 'Ahpra and National Boards recognise that there may be times when health practitioners need professional advice about their own health, and we encourage them to get that support. Practitioners should seek advice without worrying about a mandatory notification being made about them.'

# **Changes to mandatory notifications**

Early this year, Health Ministers agreed to make changes to mandatory notifications requirements in the National Law and the Health Practitioner Regulation National Law and Other Legislation Amendment Bill 2018 (Qld) (the Bill) was passed by the Queensland Parliament in February 2019.

The changes only apply to treating practitioners and intend to support practitioners to seek advice for a health issue (including mental health issues), while continuing to protect the public. This is because the circumstances for treating practitioners to make mandatory notifications are more limited than they are for other groups.

Under these National Law amendments, three of the four types of conduct (impairment, intoxication and practice outside of professional standards), which may lead to a mandatory notification, will have the same threshold for mandatory notifications by treating practitioners. It is: substantial risk of harm. A substantial risk of harm is a very high threshold for reporting risk of harm to the public.

When the amendments take effect in early 2020, they will apply in all states and territories except Western Australia, where mandatory notification requirements will not change.



# Consumer direct dental services

# A dentist's obligation

here are an increasing number of dental services available which are direct to the consumer, meaning the consumer hasn't consulted directly with a registered dental practitioner. While the convenience of these services is obvious, they aren't without risk for both the consumer and any registered dental practitioner involved.

These direct services are available for several dental treatment areas such orthodontic aligners, splints and sleep appliances. These services can be initiated by the consumer creating their own impression using materials and information provided to them. In other cases, the patient may have a digital scan carried out by the service provider at a designated location (shopfront or pharmacy), often by someone who is not a registered dental practitioner. Following this, a treatment plan is developed and the device(s) required will then be provided to the patient for use. Some of these services also offer mechanisms for remote supervision of treatment progress by a dental professional.

One of the concerns with this type of treatment model is that other dental issues, not directly related to the appliance, may not be detected due to the patient not being regularly assessed and treated in-person by an appropriate registered dental practitioner. There are also concerns about how patient

suitability (or standard of care case selection) is determined. While some companies providing these services do have a process of assessing the suitability of the appliance for each patient, this is often done by the patient completing an online assessment form themselves; therefore, there is no assessment for suitability by a registered dental practitioner.

Dentists who choose to participate in these treatment models need to understand and appreciate their level of responsibility and possible liability.

Regardless of whether or not a dentist has seen or consulted with the patient themselves directly, involvement in design of such appliances or other aspects of their provision and use may be deemed by regulatory bodies to be provision of a dental service. Registered practitioners, when providing a dental service, must ensure their professional obligations are always being met.

If a consumer is dissatisfied with the outcomes of their treatment and they're aware of a registered dental practitioner who was involved in their treatment in some capacity, they have the same rights as other patients to formally complain to regulatory authorities or make civil claims about the treatment provided by this practitioner. To defend against allegations of wrong-doing, this practitioner would need to show that:

- the treatment and/or advice they provided was to the professional standard expected;
- they are appropriately qualified and experienced to be providing that treatment and/or advice;
- the treatment and/or advice was clinically justified;
- the patient was aware of the risks, expected outcomes and limitations of the treatment; and
- detailed clinical records have been maintained, showing exactly what was done and why.

It is therefore strongly recommended that any registered dental practitioner choosing to become involved in any capacity in providing treatment through this direct model consider the risks involved and be certain these risks will be appropriately managed.

# Income Protection Insurance Facing Massive Shakeup

An overhaul of Income Protection insurance has been proposed, to stem the billions of dollars being lost by insurers each year and it could have enormous implications for anyone considering a policy.

Some of the mooted changes could come into effect as soon as April 2020 and would have an impact on all new Income Protection (IP) Insurance contracts, and potentially on any changes being made to existing contracts.

This type of insurance, also known as Disability Income Insurance (DII), can provide replacement income to policy holders if illness or injury render them unable to work.

"As it currently stands, it can protect a family financially in the event of debilitating injury or illness, providing a replacement income of up to 85 percent and allowing time for recovery without the added stress of mounting bills," said Mark Mullins, Associate Director and Representative of Hood Sweeney Securities Pty Ltd, AFSL No. 220897.

Mr Mullins said one of the most radical proposed changes would restrict the benefit payment period to a maximum of five years - from the existing benefit period up to age 65.

"After five years, where would an income come from for people still recovering from an injury or illness? How would they pay a mortgage, school their children, or put food on the table?"

The Australian Government's statutory authority, the Australian Prudential Regulation Authority (APRA) has called on the life insurance industry to urgently address concerns about the sustainability of individual IP Insurance. APRA has been concerned about IP Insurance sold to individuals due to the leniency of claims. The industry has collectively lost more than \$3 billion through this product offering over the past five years, with no signs of improvement.

APRA wrote to the industry in May 2019 requesting action to address the problems. Since then, insurers have reported further losses of \$1 billion, prompting APRA to escalate its response.

With at least one major reinsurer indicating it was no longer prepared to reinsure individual IP insurance, APRA Executive Board Member Geoff Summerhayes said there is now a genuine risk insurers may start withdrawing from the market.

"Disability Income Insurance plays a vital role in providing replacement income to policyholders when they are unable to work due to illness or injury," Mr Summerhayes said.

"In a drive for market share, life companies have been keeping premiums at unsustainably low levels, and designing policies with excessively generous features and terms that, in some cases, provide a financial disincentive for policyholders to return to work.

"Insurers know what the problems are, but the fear of first-mover disadvantage has proven to be an insurmountable barrier to them making the necessary changes. By introducing this package of measures, APRA is forcing the industry to better manage the risks associated with DII and to address unsustainable product design features – or face additional financial penalties."

APRA set a deadline for life insurers to commence a range of steps, including formulating a strategy to address the issues identified by the review, and reviewing income protection insurance product design and pricing practices to enhance its sustainability.

Some of the potential changes are listed here:

Current Income Protection Contracts	Proposed Income Protection Changes
Income based at time of application or time of claim	Income based at time of claim only
Benefit period up to age 65	Benefit period restricted to five years
Up to 85% of Income insured	Maximum 75% of income insured
Guaranteed Renewable contract	Initial contract term not exceeding five years (with option to extend based on contract at the time of extension)

# Patient information: Your Obligations to Protect a Patient's Privacy

### **Scenario:**

A dentist moved to work at another practice. The dentist created a list of patients whilst at the first practice where he had contracted and, after leaving the practice, attempted to contact the patients with information on the list.

### **Ouestion:**

Is this permissible?

### **Answer:**

If the patients have not consented to the release of their personal information for the purposes for which it was used, then the dentist will likely be regarded as having acted contrary to the standards of good practice.

# Dentists must Protect Confidential Information

It is inevitable that, during the examination and treatment of patients, dentists will collect

information about them. Information about patients can fall into a number of categories, including health information, sensitive information (such as religious beliefs or criminal record) and personal information, which is any information or opinion about an identified individual or an individual who is reasonably identifiable. According to the Dental Board of Australia Code of Conduct, good dental practice involves treating information about patients or clients as confidential and applying appropriate security to electronic and hard copy information to ensure its confidentiality. Dentists must seek consent from patients before disclosing their information, where it is practicable to do so.

The ADA in their Policy Statement 5.18 - Dentistry, Privacy and Confidentiality requires dentists in the private sector or Commonwealth government agents to have regard to the Australian Privacy Principles (APPs).

The APPs impose an obligation on relevant entities, including individuals and partnerships, not to use or disclose personal information for purposes other than the purpose for which it was collected, unless an exception applies. For example, a dentist who has taken a photo of a patient where the patient is identifiable for treatment purposes must not use it for advertising purposes,

unless the patient has given their consent. The same principle applies to the retention and use of telephone numbers, email addresses and home addresses; while they may be used for clinical purposes, such as scheduling appointments or informing patients of test results, it would be inappropriate to contact a patient for marketing purposes or other personal purposes using this information.

Section 3.16 of the Dental Board of Australia Code of Conduct stipulates that, when a practitioner moves between practices, good practice includes facilitating arrangements for continuing care. This "may include the transfer or appropriate management of all patient records, while following the law governing privacy and health records in the jurisdiction". Good practice may require practitioners to inform patients that they are departing a practice in advance. If the patient indicates that they wish to follow the practitioner to their new place of practice, the practitioner could then obtain the patient's consent to transfer their records to the new practice.

# Consequences of Non-Compliance

Practitioners should be aware that the unauthorised transfer of records from a practice may result in a complaint from that practice to the Dental Board. It may also contravene a practitioner's obligations in other areas, such as employment law, and practitioners must be mindful to adhere strictly to the terms of their engagement contract.

Patients expect that dental practitioners will treat their personal information with appropriate discretion and use it only for the purposes for which it was provided. Use of information outside these parameters, such as using a patient's telephone number without permission to contact them from a new practice, may fall below the standard that might be reasonably expected of dental practitioners.

### **Key Messages**

- Information about patients is to be treated as confidential and private.
- Dentists have an obligation to use patients' personal information only for the purpose for which it was provided.
- Dentists moving between practices have an obligation to ensure continuity of care, which can occur within the practice.
- Continuity of care may require transfer of patient records, but this must be done only with the consent of the patient and preferably, with the knowledge of the clinic owner.

- It is important that dentists adhere strictly to the terms of any contract that exists with the practice as the practice is generally regarded as the owner of the clinical records (although this may depend on the terms of the contract).
- Failure to maintain patient privacy and confidentiality may result in an investigation and action by the Dental Board of Australia.

# How Cadbury workers win for sick leave could impact Australian employers

Two Tasmanian Cadbury workers represented by the Australian Manufacturing Workers Union (AMWU) have won a Federal Court case brought by the chocolate maker's parent company Mondelez over their sick leave entitlements, in a determination that is expected to have ramifications across Australia.

Under section 96(1) of the Fair Work Act 2009 (Cth) (FWA), it states, 'for each year of service with his or her employer, an employee is entitled to 10 days of personal/carer's leave.' This provision may be expressed simply but its interpretation is quite complex. What does 'a day' actually mean?

The issue of 'what is a day' arose out of an application to approve the Mondelez Australia Pty Ltd, Claremont Operations (Confectioners & Stores) Enterprise Agreement 2017 (Mondelez Agreement). The Mondelez Agreement applied to shiftworkers working 12hour shifts and the Commission expressed concerns that these employees would not be entitled to their full 10-day entitlement under section 96 FWA. This is because traditionally 'a day' has been taken to mean 7.6 hours (a normal working day) and using this historical approach would mean that shiftworkers who work extended hours would only receive 7.6 hours of personal/carer's leave rather than 12 hours which represents their 12 hour rostered shift.

Mondelez submitted to the Federal Court that the entitlement provided for within section 96 of the FWA should be constructed according to the industrial

meaning of the word day. That is a 'notional day' consisting of an employee's average daily ordinary hours based on an assumed fiveday working week-that is, average weekly ordinary hours divided by five. For example, an employee who works 38 ordinary hours per week works an average of 7.6 hours per day over an assumed five-day working week giving them a total of 76 hours of personal/ carers leave per year.

Conversely, the AMWU constructed the entitlement as a 'calendar day' entitlement, or a 24 hours period, and that the provision within the FWA allows every employee to be absent from work without loss of pay on 10 calendar days per year. Effectively arguing that a 12-hour shift worker employee is entitled to more hours of paid personal/carer's leave than the 7.6-hour employee, but neither would lose income over a period of 10 calendar days.

The Federal Court ruled in favour of the AMWU and the workers in a split decision. The practical effect of this decision effectively means where workers are working above the average of ordinary hours per day they would be entitled to more hours of personal/carers leave. For example, 12-hour shift worker would have their personal/carer's leave paid at 12 hours per day.

Unions have heralded the decision as a great win for workers who work long shifts that are longer than the standard day and ensures they are given an entitlement to enough personal/carers leave that is reflective of the hours they work. However, this decision poses a very real threat to substantial cost implications for employers.

In light of this decision, all businesses should be aware of the following:

- Where personal/carer's leave and/or annual leave entitlements are expressed in an enterprise agreement or an employment contract in terms of hours per annum rather than in days, employers may need to ensure that they have a mechanism for this leave entitlement to be 'topped up' for any shift workers who work in excess of 7.6 hour shifts.
- Where payroll systems are used to calculate leave entitlements employers should consider checking whether employees are accruing entitlements on an hourly or daily basis. If shift workers are accruing entitlements on an hourly basis, adjustments may need to be made to ensure that workers are receiving their proper entitlements under the FWA.

If this represents a departure from the manner in which personal/ carer's leave has been managed in your practice, this could result in a systemic underpayment issue which will require redress.

# STUDY CLUB # 6

Restorative Implant Dentistry

The ADASA Recent Graduates Committee had the pleasure of hosting our final study Club with a focus on "Resorative Implant Dentistry".

from the Oral Rehabilitation and Implant Specialist Centre, Dr Manuv Suri and Dr Amandeep Badwal. This was a particularly relevant topic for recent graduates, whom may have not been exposed to the clinical Sirona, and their representative Karmel Harrison. aspects of implantology in dental school.

The informative presentation gave a broad overview of implant dentistry, covering topics from patient selection and surgical considerations, to clinical tips and tricks for the restorative aspect. Dr Badwal discussed the various patient factors to consider in the treatment planning of an implant, in particular those such as smoking, bisphosphonates and uncontrolled diabetes, which can all result in poorer wound healing. He also highlighted the site-specific factors to assess including the soft tissue profile, angulation of the dentition and degree of mouth opening, as well as CBCT radiographic examination to assess the 3D bone availability.

A helpful tip, particularly when replacing an anterior Pictured: Dr Amandeep Badwal (speaker), Dr Sophie missing tooth, was that the smallest implant available Roberts (RGC), Ms Karmel Harrison (Dentsply Sirona), Dr is 3mm in diameter. Therefore a minimum space of Saloni Singh (RGC). 6mm is required to allow for 1.5-2mm of space for adjacent soft tissues.

Dr Badwal explained that ideally the person who is going to place the implant should also extract the tooth, as favourable cases can facilitate immediate implant placement, and prevent a second surgery. In cases where this is not possible and a provisional restoration is required, Dr Badwal explained that a suck-down stent or flangeless acrylic denture are the preferred options to prevent pressure of soft-tissues and thereby permit favourable healing.

Over the 90 minute presentation Dr Suri and Dr Badwal provided an explanation of the steps involved in planning, placing and restoring implants; highlighting the roles that the general dentist, specialist and laboratory technician may play in the process.

# Donald Stuart Worley OAM

The ADASA was saddened to learn of the recent passing of Dr Donalad Worley OAM. He will be missed by all.

Born 14 August 1934 Died 31 December 2019

Don attended Unley High School where he had a distinguished career, topping the state in Latin and runner up winner of the Tennyson Medal for English. He was awarded a scholarship to Adelaide University where he chose Dentistry, not wanting the after-hours commitments of medicine that would interfere with family life and, despite the intervention of National Service in Victoria, was dux of his class as they graduated in 1956.

Don accepted a position as a locum in Trevor Martin's practice on South Road in Clarence Gardens and, in 1957, married Barbara. They lived briefly in Glenelg, before Trevor Martin returned from England and Donald and Barbara decided to follow an Australian medical and dental tradition to board the Fairsky and sail in October of 1959 to London to 'practise on the poms'.

In 1963, Don joined the dental practice of Basil, Ray and Brian Leach, who, along with Graham Parry, and later, David Miles, occupied the fourth floor of Da Costa Building in Grenfell St in the city. He would stay in this practice for the remaining 50 years of his working life as a dentist

Don was a Life Member of the ADA, serving on the Conduct Committee for decades, pioneering four and sixhanded dentistry and teaching the radiography course for dental assistants. Commencing in the 1960's the ADA ran a Dental Radiography Course for dental assistants as an extension of a Dental Assistants Course. Don voluntarily conducted that course from the mid 1960's to 1976. This training was of clear benefit to the young assistants and in turn the dental providers and their patients. His own dental assistants were always special people, more family than work colleagues.

As they drove to a National Dental Conference in Melbourne in Feb 1967, Don and Barbara's lives changed forever. Unfortunately, this afternoon they both ended up asleep at the same time, and with Barbara driving, the car rolled just out of Nhill. Don, not wearing a seatbelt, was thrown clear out of the car and hardly had a scratch. Barbara, wearing a now recognised unsafe sash-only seatbelt, was caught inside and never walked again.

They never accepted the miserable prognosis given them by the doctors of that time,
Don supported Barbara to re-engage with sport. Regular

sporting competitions were just commencing between State-based teams and this required 'able-bodied' assistants to provide support for competitors. Don assumed this role and it was suggested that "he take his camera to take a few shots".

Thus began Don's extraordinary globally recognised contribution to filming and promoting sport for the disabled. A meeting in Heidelberg was followed by the FESPIC games in Japan in 1975, and Paralympics in Toronto in '76, Arnhem in 1980, Stoke Mandeville in '84 and Seoul in '88 in addition to multiple national competitions. Don photographed them all, starting with 8 mm, Super 8 and eventually 16 mm film and video.

The ABC screened his films, and subsequently took over responsibility for providing TV coverage of the Paralympics. Recently, his entire collection was accepted by the National Film and Sound Archive of Australia as they are the only existing record of these historic early competitions.

He was ahead of his time in recognising the power of the picture to change people's perception to see the ability rather than the disability, resulting in widespread reform for equity in civic and sporting policies for people living with a disability.

In 2017, he was awarded the Medal of the Order of Australia in the Queen's Birthday Honours List for service to sport for the disabled as a documentary film maker.

Don sang and made great friends as a tenor in the Way Chorale, Chandos Choral, Kapelle Singers and Harmony Choir, and to his great joy, in massed Adelaide choirs to sing the great choral works including Beethoven's Choral Symphony under the baton of Vladimir Ashkenazy with the London Philharmonic Orchestra at the Adelaide Festival Theatre. He knew Handel's Messiah off by heart. He continued to love classical music till his dying day.

He was a creative, dedicated, and quiet achiever. He would always wish others to be recognised rather than himself.

Don is survived by three sons, 15 grandchildren and six great-grandchildren.
