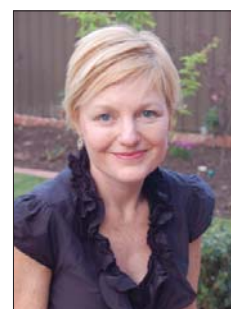

ADASA's 2013-2014 year got off to a positive start with the office functioning more efficiently in our newly renovated ADASA House and with the naming of the meeting room by Dr Jack Gaffey in honour of Dr Karin Alexander at the Christmas Party. Karin's reaction was delightful and must be recorded here for posterity; Karin was so surprised that she was rendered speechless! The Council Room was named for the late Dr AJ Bloomfield. The naming of these rooms recognises the contributions of Drs Alexander and Bloomfield have made to the Australian Dental Association as federal presidents.

In February, Councillors met to develop a new Business Plan for ADASA. Through a number of ongoing activities and new initiatives, the business plan focuses on five key areas:

1. Public education campaigns about oral health
2. Advocacy for greater access to dental care for all South Australians
3. Professional development and support services to members
4. Consulting with members and stakeholders
5. Implementing best practice governance standards

New initiatives included an education event for dental assistants and establishment of the Practice Managers' Network. ADASA has also added several subsidised continuing professional development events to the annual calendar including a full-day clinical seminar, two evening seminars dedicated to practice issues and an additional Study Club. The governance charter has been revised, meeting procedure simplified, and the new, modernised Constitution has

been accepted by the membership at a Special Meeting in August. ADASA hosted two successful Practice Accreditation Seminars with members and practice managers gaining valuable insight into a process that is not as arduous as originally touted. More than 100 practices have either successfully completed the accreditation process or are working through it.

At the May branch meeting Mr Paul Cassidy from Guild Insurance spoke on indemnity insurance and members in attendance voted to accept the recommendation from the Awards Committee and Council to bestow a Distinguished Service Award on Dr Janet Scott for her many years of dedicated service to our Association and profession. The August branch meeting was enhanced by short presentation from Dr Balya Sriram on early intervention orthodontics and our dinner guests were entertained at their tables by illusionist Matt Tarrant. Now to the Child Dental Benefit

Schedule (CDBS) that replaced the replaced the Medicare Teen Dental Plan, when it began on 1 January. The CDBS, administered by Medicare, is means tested and available to children, aged 2-17 years, of families in receiving of Family Tax Benefit Part A. The CDBS provides rebates for a limited range of basic services delivered in the dental surgery (both private and public). Unfortunately, the administrative, consent and billing arrangements are complex and benefits are not paid for preventive services nor for in-hospital services. With the change to eligibility criteria announced in the May Federal Budget it's likely that fewer children are now eligible. ADASA has recently become aware of administrative "breaches" being identified by the Commonwealth and again strongly advises members to take care to adhere to the rules of the CDBS.

There was good news and some not-so-good news for dentistry in the 2014-15 Federal Budget. A 12-month deferral of indexation of the Department of Veterans' Affairs dental and allied health provider payments was announced and described as creating savings of up to \$35.7 million over four years, to be invested in the proposed Medical Research Future Fund. A sum of \$10.6 million over four years was allocated to an integrated oral health program with a focus on preventive services for Indigenous children in Northern Territory communities. No other state or territory received equivalent funding.

President's Report



The start of a new National Partnership Agreement for Adult Public Dental Services was deferred to mid-2015. This agreement represents an extra \$93 million for South Australia over four years, but the 12-month delay means waiting lists for public dental services are growing. The deferral has also limited the SA Dental Service's ability to direct patients to private practice for care under the emergency, general and other schemes.

The national Flexible Dental Grants Programme was cut with more than \$200 million lost from the Commonwealth Department of Health. Again with savings diverted to the Medical Research Future Fund. The creation of this research fund might be a plus but are patient services being sacrificed for research? Will savings from dental initiatives be quarantined for dental research and deliver a benefit to our nation's oral health in the long term?

It's not surprising the Commonwealth rationalised agencies and their activities in the budget which announced that the functions of Health Workforce Australia and the Private Health Insurance Advisory Council would be carried out by the Department of Health and the Private Health Insurance Ombudsman would move to the Office of the Commonwealth Ombudsman.

The state budget was released in June with almost \$900 million of Commonwealth funding having been withdrawn across the portfolios and the Treasurer telling us that over \$300 million dollars of savings needed to be made in health. Savings measures were unclear then and despite the fanfare made this month about the Minister's plans for the South Australia's hospitals, the changes to our health system remain unclear. Without federal input this financial year expenditure on the State-funded dental schemes was predicted to be \$5.5 million down from \$18 million in the previous 12 months. The SA Dental Service, however, remains hopeful that the deferred National Partnerships money will become available for the 2015-16 financial year.

The proposed deregulation of the tertiary education sector is still a matter of debate. It seems unlikely that deregulation will lead to larger classes in dental schools and a worsening of the underemployment and unemployment of dentists. Australia doesn't have enough public and university dental chairs for

student placements, and it doesn't have enough dental academics to support any expansion. Will the potential market for fee-paying dental student places shrink following the media on oversupply? This year the University of Queensland announced the closure of its Bachelor of Oral Health program - the second in Queensland to close just a few months before opening a new clinical facility. The reduced number of oral health students in Queensland will be partially countered by the larger intake proposed by the University of Newcastle despite there being figures showing that it's more expensive to teach oral health than dentistry. Sometimes the thinking of university administrators doesn't seem to add up. Sometimes the thinking of government administrators and politicians doesn't seem logical either. Which brings me to the long-running saga of the University of Adelaide School of Dentistry.

ADASA Councillors and the members of a Special Purpose Committee have dedicated many hours to the position of the dental school since early November 2013 when public comments by the Vice Chancellor of The University of Adelaide made it clear that the future of the School was at risk. Dr Jack Gaffey, then President, immediately spoke out and grabbed considerable media attention. Soon after this, concerned members established an advocacy group that was quickly brought into ADASA as a special purpose committee and named the Dentistry Action Group. Advice has been sought from a lobbyist, numerous letters have been written, a petition instigated, and many meetings held with politicians of all persuasions, including the SA Minister for Health, with Senior Management in SA Health and with the Chancellor, Vice-Chancellor and Councillors of The University of Adelaide.

The Action Group initially supported for the university's favoured position to co-locate Medicine, Nursing and Dentistry in an Integrated Clinical School near the new Royal Adelaide Hospital. Protracted negotiations between the university, State and Commonwealth seemed to go nowhere and it was evident that the School of Dentistry, including a clinical facility, would not go the West End. This was confirmed in May when the university announced a 13-storey building for Medicine and Nursing.

Come the end of May, Commonwealth financial assistance had not been

forthcoming and the State's financial position was not strong. Failure of the university and the State to agree on how to replace or upgrade the Adelaide Dental Hospital put accreditation of the undergraduate and specialist clinical degrees and South Australia's world-class dental school at risk. The university did, however, receive a written guarantee of student clinical placements for several years from the Premier.

The SA Dental Service and School of Dentistry have worked together well for many years, and I doubt that anyone in our profession predicted the Minister for Health's mid-June announcement that the South Australian government would tender for a joint public dental service and dental school. The University of Adelaide responded by publically announcing that the School of Dentistry will continue and that it will build a clinic on the main North Terrace campus.

ADASA recognises that its members hold a range of views on this matter: some members are worried about oversupply and underemployment of dentists and don't want a dental school in South Australia, others want a school but have no preference for any particular university and many want to see the existing University of Adelaide dental school remain. Our profession is aware that the University of Adelaide and other universities registered for the tender process. I'm certain that the proposals addressing the very detailed and demanding criteria submitted in October would have been of high quality. ADASA wants one strong, world-class dental school for the benefit of South Australia, the public and our profession. It is anticipated that the outcome of this unprecedented tender process will be known by the end of the year.

AHPRA and the Dental Board of Australia have been very active this year. There has been an audit of dental practitioners for the 2013 registration year relating to compliance with the guidelines for criminal history checks, professional indemnity insurance, recency of practice and the first three-year cycle of continuing professional development. The Board is engaged in developing a list of competencies for each of the dental specialties and is reviewing the process used for assessment of specialist registration applications received from specialists qualified off shore.

President's Report

The outcome of the AHPRA Review of Scope of Practice was good news with the dentist remaining the leader of the dental team. The word supervision was removed from the guidelines but Allied Dental Practitioners (Dental Hygienists, Dental Therapists and Oral Health Therapists) need to work within a "formal structured relationship" with the dentist. So we return to the relationship set in place by the former Dental Board of SA. All ADASA members are encouraged to discuss and document the working relationships, expectations and duties off staff in the practices they work in.

Additionally the Board has issued numerous documents requiring our attention - an interim policy on tooth whitening, an interim position paper on the use of botulinum toxin, a policy on social media, a revised code of conduct, revised guidelines on mandatory reporting of practitioners and revised guidelines on advertising. Despite my airing concerns about the nature of advertising and websites of some ADASA members in Dental Insights. I'm sorry to write that I still see testimonials and statements that could be misleading. For the safety of our patients we all have moral and ethical responsibilities to take care with advertising.

ADASA continues to meet regularly with senior staff in the Adelaide AHPRA Office and despite dissatisfaction with the first three years of the national Registration and Accreditation I believe practitioners can look forward to a more



open relationship and improved access to information.

ADASA has remained one of the branches in the consortium with Guild Insurance. The other branches are ADANSW, ADAV and ADATas. A majority of ADASA members are insured with Guild representing about 12% of Australian dentists insured with the company. Under the consortium agreement ADASA has received \$140,053 since the start of the current financial year. This money is allocated by our Branch to support meetings, events, and CPD for all members as well as the general expenses of running the Branch.

From 1 July 2014 the branch covers the full salaries and cost for our Community Relations Officers. In our Branch the CROs are retired dentists who are no longer registered. Their many years of practice make them well positioned to talk with members of the public who have concerns or complaints about member dentists. CROs are available to discuss issues of concern, a potential complaint or notification with all members. If the need for legal advice is identified the CROs work with Meridian lawyers for Guild-insured members and refer members insured with other companies on to their legal advisors.

Dental Health Week ran in August with Federal ADA and the branches focussing on this year's theme of "Sugar Bandits" - those people who feed children rather more sugar than they ought. In South Australia the pre-school media launch was very successful and was followed by a lot of television, radio, print and online media. ADASA's Public Relations Committee also ran several other media campaigns for the education of the South Australian Public.

ADASA members have benefitted through the ongoing work of the Practice Support Committee that, among other duties, prepares articles and bite-sized reminders for Dental Insights. The Audit Committee continued to move away from the traditional focus on financial management and reporting by exploring and implementing systems to ensure that risks to our association are minimised, business continuity plans

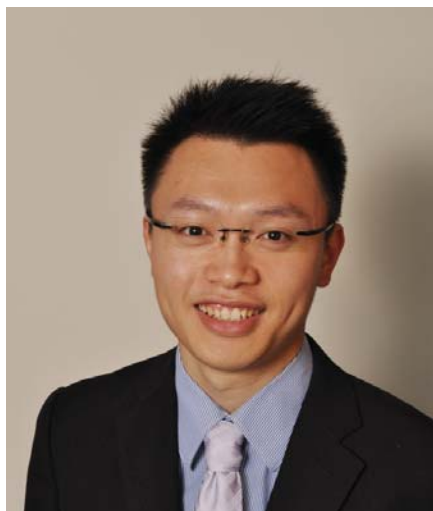
are in place and that ADASA remains compliant with its responsibilities under State and Federal Legislation.

The Recent Graduates Committee hosted a well-subscribed series of Study Clubs and the annual Learn From Our Experiences Seminar for the final year dental students.

Data reveal that the pattern of membership applications, renewals and resignations has remained the same for ADASA over many years. While there are ups and downs in the annual cycle the good news is that ADASA's membership has grown while other branches are experiencing declines. Our challenges are to maintain the growth in membership and to convert current final year student members into full members.

There are many other items of business that were dealt with by ADASA this year and I acknowledge the work of all committee members, Councillors and staff for their input and dedication throughout the year.

Treasurer's Report

I am pleased to report to members that the ADASA has produced a consolidated operating surplus of \$145,847 for the financial year ended 30th June 2014. This is a good result and represents an improvement of \$83,653 over the projected budget for 2013-2014.

It has been a busy year for ADASA this financial year. The refurbishment of ADA house was completed under budget. We now have our own facilities to conduct continued professional development (CPD) and social events as well as providing an additional income stream when it is hired to community groups and other CPD

providers when not in use. Professional advice recommends that after the refurbishment the depreciation of the building be set at 10 per cent and council has accepted this recommendation.

To assist members with CPD, ADASA continues to run many CPD events at subsidised rates. This year as a service to members, the branch arranged for an international speaker to present and this was well attended resulting in good financial result for this event. The Recent Graduates Committee continues to run the popular study group with sponsorship for the first time this year to help offset costs. There has been a small improvement in magazine advertising compared to last financial year. We are also encouraged by continued growth in our membership.

There were a number of challenges faced by our branch this year. With the benefits from the redevelopment comes a loss of revenue from rental income of unit three. Due to the current economic climate, interest rates for our deposits continue to fall and there has been a reduction in sponsorship and commission. Whilst returns from bank deposits are lower, council is mindful of the need to manage member funds in a conservative and fiscally responsible manner and thus has elected not to invest in options with higher risk profiles.

Despite these impacts on our revenue stream, council understands the need to

keep increases in branch subscriptions to a minimum. Having considered the financial analysis prepared by the branch accountant and CEO through the audit committee, council recommended that an increase in branch subscriptions be limited to the general consumer price index of 2.9 per cent. This balanced approach was accepted at the May branch meeting.

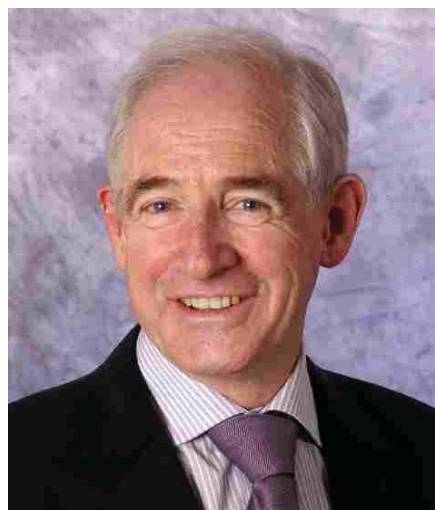
In accordance with the requirements of our constitution, ADASA's financial statements are audited annually by an external auditor. Council has recommended the appointment of BDO as our external auditor for another year. On behalf of council, I acknowledge and thank our external auditor for their services. I would also like to take this opportunity to thank our branch accountant Julie Herring for the detailed yet streamlined monthly financial reports, profit and loss reports for events and various other tasks to assist council with its duties. I thank members of the Audit Committee for their valuable input and advice throughout the year and Mr Peter Gardner our CEO for his participation with the committee.

I am pleased that our finances remain strong and together with solid financial management and reporting systems in place, our branch is well placed to continue to serve our members and achieve its objectives in years to come.

The only business of the Constitution Committee this year has been the continuation of the review of the ADASA Constitution.

After governance seminars in 2009, council decided to carry out a comprehensive review of our constitution. This task was then referred to the Constitution Committee. Following legal advice, the recommendation was to draft a new constitution rather than try to modify the existing one. We sought comment from members on several occasions and received some very valuable feedback. In September 2010 Council held a meeting in the Barossa Valley at which a Special Purpose Committee was formed for this purpose.

We have now completed this task and the new constitution was adopted at a Special General Meeting of the Branch in August at the Wine Centre.

What does the new constitution look like?

The new constitution has a different structure from past documents but embodies most of the past constitution with some changes which address the modern requirements of the association.

The objects are that it is a short, precise document which is easy to read and that it embodies the aims and philosophies of the association. It separates the details of everyday management from

the rules governing the Association and implements these in By-Laws.

The Constitution document is available for all Members to read on the ADASA web site.

Council will now have the ability to modify its management protocols in an efficient and easy manner and Members will not lose the important ability to control the way our Association acts to represent their interests and the provision of services to the public.

I thank the Committee members for their time and efforts this year and for the last three years. We have enjoyed the process of reviewing the present Constitution and hope that we have produced a document that will guide the Association well into the future.

The ADASA Public Relations Committee has enjoyed another successful year. "The Hidden cost of tongue piercing"

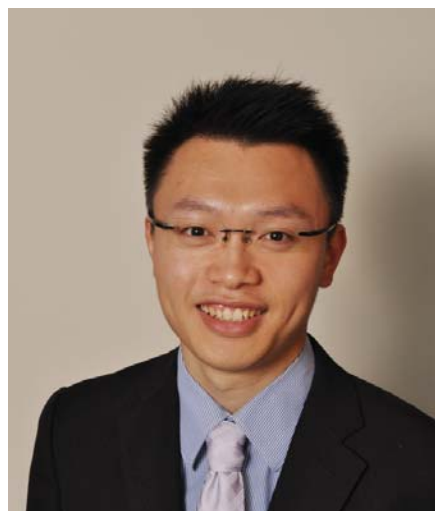
The aim of ADASA is to establish and to maintain an in house Public Relations person and hence council has decided to not renew the recently expired contract with Corporate Conversation public relations firm.

The ADASA Recent Graduates Committee (RGC) was established to assist students and graduates in the transition to professional members of our dental community.

This has been a busy year for RGC. Our committee currently consists of me, Drs Stuart Renigers (Deputy Chair), Sharyn Borrett, Jonathan Christo, Gabrielle Klingberg, Alex Lam, Charlotte Marriot-Smith, Clementine Mellor, and Keng Soon Yeoh. We thank outgoing members Drs Kim Christo, Susan Clift, Jamie Do, Lloyd Hurrell, David Power, and Saumya Rana for their contribution.



We started the year with the Annual Lawns Bowls evening, co-hosted with the Adelaide University Dental Students Society (AUDSS). The Toorak Burnside Bowling Club was chosen by the committee as it offered improved conditions, catering options and easier parking. Council has also decided to award a perpetual trophy from 2015 to the winners of this event, which will be housed at ADA House.

This year saw many improvements to our popular study clubs. With refurbishment of ADA House completed, we were able to host more diversified study club meetings with increased frequency and capacity. We were able to host two hands-on study clubs with the support of sponsors whilst having systems in place to delivering unbiased CPD content as recommended by the Dental Board of Australia guidelines.

We were privileged to have eight CPD presenters in six study club meetings this year. Our study club program began with Dr Sharon Liberali presenting on "Can your sexual habits predispose you to oral cancer". Sharon provided the latest update on oral cancer with a particular focus on HPV-related oral cancers and shared her clinical experience in communicating with patients on this sensitive subject. Next we had Dr Jonathan Christo who presented on "Taking the nerves out of endo - Tips for predictable treatment". This event was very popular, well attended, and received excellent feedback. The third study club presenter, Dr Wayne Chen, provided an evidence based presentation on "An assortment of aligners...what they can really do". Wayne updated attendees on a vast range of new orthodontic treatment modalities, summaries of the literature available thus far, indications and limitations as well as clinical hints on their use. Our annual extended study club meeting was held on Saturday and this year's theme was oral surgery. Drs Andrew Cheng, Davor Hribar, and Zahi Khouri presented on "Clinical management of impacted lower wisdom teeth", "Implant management of edentulous maxilla" and "Red flags in oral surgery" respectively. Over half a day, topics covered included clinical cases illustrating challenges in differential diagnosis, treatment planning considerations and practical clinical tips. We concluded the year with two hands-on events. The suturing workshop was facilitated by Drs Davor Hribar and Bill Oberdan covering the theory with hands-on practice of

various suturing techniques. The final study club meeting was a hands-on prosthodontic workshop on implant over-dentures by Dr Yohan Thomas and this event was fully subscribed. On behalf of the committee I would like to thank the presenters and sponsors for their support of recent graduates as well as attendees for their kind words of support. We look forward to bringing members both educational and interesting study club meetings for 2015.

Our committee's other role is to facilitate the introduction of dental students into the dental profession. The annual "Learn from our experiences" event to final year dental students was very well received. Presentations from our president, Associate Professor Janet Fuss and Drs David Power, Keng Soon Yeoh, Sanjaya Gamage, Stuart Renigers, Isaac Liao and Ms Joanne St Clair covered a vast range of topics. These included CPD requirements, experience during the first year after graduation, public vs. private practice, rural clinical experience, university tutoring, RACDS pathways, and professional indemnity insurance. To further assist our dental students, we compiled the Employers Guide for the graduating class which was provided to members in print and available online from ADASA and ADA Inc.

The year concluded with the annual cocktail party at the Gallery on Waymouth. With improved sponsorship and planning we were able to improve the venue and catering whilst reducing cost to attendees. This event was well attended with attendees spanning the full spectrum of ADA SA membership from students, recent and non-recent graduate dentists, and specialists.

On behalf of the committee I thank our president Associate Professor Janet Fuss for her support of recent graduates. I thank the ADASA administrative team Gerry Hunter, Sally Queale and Catherine Waite for their tireless efforts throughout the year. Without their contribution the committee could not have brought our projects and events to fruition. Finally I would like to take this opportunity to recognise and thank each committee member mentioned above for their input, support, and commitment as volunteers to the association.

This year we welcomed A/Prof James Dudley to the Committee, replacing Dr Don Worley who retired from practice last year. I would like to say that this

has been a quiet year for the Review Committee, but unfortunately we have been quite active. The Community Relations Officer (CRO) has continued to brief us on events at most meetings, and where necessary, the Review Committee has offered suggestions for resolving some issues. The main issues this year have been advertising (yet again!) and patient expectations, especially from dentures.

Despite our suggestions and even warnings in Dental Insights, advertising continues to be a source of complaints. Once more, the committee has reminded members to be aware of the revised AHPRA guidelines in relation to advertising, as AHPRA is taking notice and if members flaunt the guidelines, they may be asked to account for their actions.

The committee has also worked in conjunction with the CRO to counsel members who may have been the subject of proceedings. A roster has been established with members being available to discuss matters with the CRO and it has also been working with the ADA office staff and the CRO to talk to members who might be concerned and/or distressed about a matter or potential complaint when the CRO is not in the office.

By monitoring the types of enquiries that the ADASA receives, and any subsequent complaints, we are able to monitor trends and from this we have been able to present articles for Dental Insights magazine on various topics, in an effort to help members. We are continuing this analysis to include year of graduation of the member concerned and also the location of the practice, again to see if there are any trends. If we can spot a trend emerging, hopefully we can address it before it becomes a major problem. Not surprisingly perhaps, is a recurring theme of communications or lack thereof when matters are taken further by patients. I have attended several council meetings this year using Skype following the ADASA's purchase of a web camera and a reasonable sound set up. Following a meeting on Skype is not easy but it does cut down the need for some trips to Adelaide and has

been particularly useful when I have had other travel for ADA scheduled close to a council meeting.

Another successful Limestone Coast Partnership Seminar was held in September this year at the Barn Palais in Mt Gambier with over 130 attending. I thank Dr Janet Fuss (Dental School Representative) and Dymphna Cudmore (SADS Representative) for their efforts in doing a large proportion of organising a very smoothly run event.

The dental workforce is slowly growing in the Limestone Coast area probably due to the increased dental workforce which is oversupplied in the metropolitan areas. SADS has also substantially increased the size of their clinic in Mt Gambier and it is hoped that the excessively long waiting lists in the area can be reduced to an acceptable level.

Federal Councillors' Report

The Federal Council of the Australian Dental Association Inc. met at its St Leonards premises in November 2013, April 2014, and August 2014.

Report of November 2013

Council Meeting

The major items covered at the meeting included the following:

Finances

The Treasurer's Report as to the financial position of the association was received and accepted. It agreed that the annual accounts were then forwarded to the the association's Annual General Meeting for adoption.

Discussion about implementing a possible annual subscription instalment payment scheme was discussed and this issue was to be considered further.

ADA Awards

Following recommendations from the Honours and Awards Committee, Dr Geoff Knight and Professor Laurie Walsh were awarded the ADA Meritorious Service Awards with Drs Len Crocombe and Bruce Simmons being awarded the ADA Service Medallion.

Recent Graduates Advisory Panel

A Recent Graduates Advisory Panel was formed. The terms of reference of this group will be to encourage the engagement of recent graduates in the

affairs of the association with a view to further increasing its relevance to recent graduates.

ADA Strategic Planning

Lengthy consideration was given to future strategies of the ADA as a preliminary step in the development of the ADA's strategic plan for 2015 and beyond. The existing strategic plan (2013-14) was also reviewed. A report benchmarking the targets and measures outlined in the operational plan within the ADA Strategic Plan was received.

Child Dental Benefits Schedule

Detailed presentations were provided on the Child Dental Benefits Schedule (CDBS). The committee discussed seeking deferral of the scheme's commencement to ensure that all rules and related administrative requirements were sufficiently clear so that members could safely participate without fearing adverse financial consequences. It was agreed the matter would be discussed with both the Minister of Health and departmental representatives.

Health Workforce Australia

HSW representatives Ms Brenda Wraight and Ms Maureen McCarty, gave a presentation to council on the preliminary findings of the HW 2025 Oral Health Project. While council was not permitted to reproduce the findings in this report, we can note that the report concurred with the ADA's view that there will be a significant oversupply of dentists, dental hygienists, dental therapists and oral health therapists by 2025 unless there is either a reduction

in the number being trained or allowed to enter into Australia through migration pathways, or there is a substantial increase in demand for services. On the results presented, there is clearly no justification for any expansion of workforce or scope of practice of allied dental practitioners.

Continuing Professional Development

A critical appraisal was undertaken of the delivery of ADA Inc. CPD to members. With current contracts for provision of ADA Dental Files, ADA Digital Medical Library and the ADA's library due for renewal, council analysed the best value options for members.

Dental Sustainability - Amalgam

A proposal was put forward to council by the Special Purpose Committee on Dental Sustainability for an amalgam waste study. The study is designed to assist stakeholders from the dental profession, dental industry, and environmental regulation to determine the extent of amalgam waste entering the environment and whether there is a need for additional amalgam waste management measures. The necessity for this follows the recent Minamata Convention entered into. Council agreed to commission the study.

ADA Policies

A "Social Media and Dentistry" policy was adopted as new Policy Statement 6.24 and amendments were made to 16 other ADA policies. Details are available on the ADA website.

Federal Councillors' Report



Federal Executive Election

Dr Karin J Alexander was reappointed President, Dr Carmelo Bonanno was reappointed vice president, Dr Rick J Olive was reappointed treasurer and Dr P Hugo Sachs and Dr Terry K Pitsikas were reappointed as executive councillors.

Report of April 2014

Council Meeting

Finance

The Treasurer provided a budget report for the first eight months of the 2013-14 financial year. The report indicated finances were proceeding in accordance with budget expectations.

The budget for the 2014-15 year was presented and approved by Federal Council following close analysis of the association's expenses. The budget catered for a general CPI increase in subscriptions together with some additional provision associated with increased costs of services to members.

Membership

Council approved instalment payments for membership subscriptions and ADA Inc. and the branch are working to implement this.

Membership in all categories of the ADA stands at 14,608.

A report was presented to Federal Council in relation to a rebranding of the association.

Honours and Awards

Federal Council granted the following awards.

- » ADA meritorious Service Award - Dr Stuart Gairns (WA)
- » ADA Service Medallion - Dr Brian Bishop (WA); Dr James Robertson (Vic); Dr Simon Sheed (Vic); Dr John Davies (WA) and Mr Peter Cronin (NSW).

Strategy and Governance

The Australian Dental Association Strategic Plan was reviewed.

Detailed discussion followed in relation to whether reform was required to the make-up of Federal Council. Council

discussed creating maximum terms of tenure for councillors, reflecting the view that greater diversity of age and background may allow council to better reflect the membership. Council felt no alterations were necessary at this time.

Affiliation

The Australian Society of Forensic Odontology was approved by Council as a Category A Affiliate with the Association.

Federal Dental Health Programs

A draft paper was presented to Council updating the ADA's Dental Access program. The general tenets of the plan were approved by council with the direction that federal executive continues to develop and refine the program. The paper would be presented again to federal council at its August 2014 meeting.

ADA Foundation

Federal Council approved the appointment of Mr David Owen, an existing ADA Foundation Advisory Board member, to be chair of the ADAF for the ensuing year. Dr Karin Alexander was appointed Vice-Chair, with Drs Alexander, Fryer, and Bonanno being appointed as Trustees (ADA Inc.) Advisory Board members.

Australian Dental Congress

A report from the Federal Sales and Events Manager in respect to the 36th Australian Dental Congress to be held in Brisbane was considered. Registration fees for ADA members will remain at the level applicable for the 35th Australian Dental Congress held in Melbourne in 2013.

A/Prof Janet Fuss was appointed Congress Chairman for the 37th Australian Dental Congress to be conducted in Adelaide in 2017 with Dr Alan Broughton appointed Chairman of the Scientific Committee.

Private Health Insurance

Federal Council considered the recent activities of a number of health funds seeking to provide provider recognition to dentists providing treatment to the funds' members. An issues paper and strategy were reviewed and approved for implementation in coming months.

International

Federal Council granted approval for Federal Executive to investigate the ADA Inc. hosting the FDI World Dental Congress in 2018.

Policies

New Policy documents entitled 'Non-Communicable diseases'; 'Oral and systemic disease'; 'Bisphenol-A in dental restorative material'; and 'Oral health and social determinants of health' were approved, and amendments were made to 12 existing Policies.

Report of August 2014

Council Meeting

Dr Angela Pierce attended her first council meeting with Dr Mark Hutton following Dr Karin Alexander's decision not to renominate.

In addition to reviewing the performance of the Association in all of its key performance indicators including fiscal management, membership statistics, and constitutional matters, Federal Councillors engaged in fruitful discussions relating to the ideal dental funding model, the role of private health insurance within the dental environment and, most importantly, the results of the recent membership survey.

Membership Survey

The results of the survey were discussed in detail by Federal Council and while more analysis is required, the preliminary findings indicate the ADA needs to communicate better as to what the Association is doing for its members. Federal Council previously approved a proposal for rebranding of the Association and as that work draws closer to conclusion members will also start to see changes to ADA's communications material.

Standing Committees

As a means of reducing the time required for individuals to attend committee meetings in person, Federal Council approved installation of high quality video conferencing equipment at the Association's offices in St Leonards. While there will be a capital cost to set up the facility, the costs will be fully offset by the savings in reduced travel, accommodation and catering costs.

Federal Councillors' Report



Constitutional Changes

A number of proposed constitutional amendments were presented to Federal Council along with subsequent changes to some By-Laws. These amendments will be considered at a Special General Meeting of the Association to be held in November 2014. The proposed Constitutional changes relate to the date of appointment of Federal Councillors, instalment payments and support for partners of deceased members.

Dental Funding

Federal Council has continued to work on the ideal funding model for dental care in Australia. This work is expected to be conducted at the November meeting of Council. The model builds upon the ADA's Dental Access proposal originally developed and endorsed in 2009.

Private Health Insurers

The quality and significant number of submissions made recently relating to private health insurance, including the Private Health Insurance Amendment (GP Services) Bill 2014, Out-of-Pocket Costs Inquiry, Competition Policy Review and subsequent attendance at the various associated Senate inquiries were all noted by Federal Council.

As increasing numbers of complaints are being received from members about the anti-competitive behaviour of some private health insurers, there was general agreement that Federal Executive should continue to raise the matter with the Federal Health Minister and the Australian Competition and Consumer Commission at every opportunity.

ARCPHO

Professor Marco Peres and Dr Liana Luzzi from the Australian Research Centre for Population Oral Health provided Federal Councillors with an update on current research projects being undertaken by the Centre. The presentation included an important update on progress towards the next National Survey of Oral Health which was last undertaken ten years ago. It is hoped funding for this project will be confirmed shortly so the project can commence in the near future.

Australian Dental and FDI World Dental Congresses

Federal Council noted a report from the Local Organising Committee of the 2015 Australian Dental Congress, to be held in Brisbane from 26-29 March 2015, which included details of the Scientific Programme and the preliminary exhibition floor plan.

In addition, Federal Council was provided with a report regarding the ADA hosting a FDI World Congress. After reviewing the secretariat's report it was determined it would be preferable to conduct the FDI event in 2019. This would replace the Australian Dental Congress which would have been held during that year.

Dental Practice Accreditation

Federal Council was provided with an update on practices participating in voluntary practice accreditation. To date, 652 practices have achieved accreditation with another 314 going through the process. Recently, 600 practices were surveyed about their experience with the process; more than 97 per cent of respondents reported they will continue to seek ongoing accreditation in the next cycle.

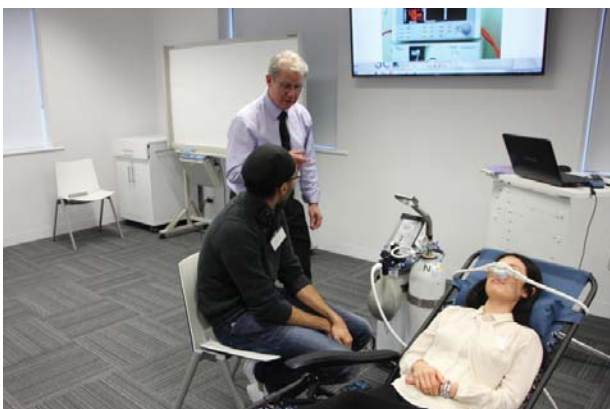

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial report is a general purpose financial report that has been prepared in accordance with Australian Accounting Standards, Interpretations and other authoritative pronouncements of the Australian Accounting Standards Board and the Associations Incorporation Act 1985.

The financial report was approved by the committee as at the date of the statement by members of the committee.

The financial statements cover Australian Dental Association South Australian Branch Incorporated as a single entity located and incorporated in South Australia. The entity is not-for-profit and the financial statements are presented in whole Australian dollars.

The following is a summary of the material accounting policies adopted by the association in the preparation and presentation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

(a) Basis of Preparation

Historical Cost Convention

The financial report has been prepared under the historical cost convention, as modified by revaluations to fair value for certain classes of assets as described in the accounting policies.

(b) Revenue Recognition

Subscription revenue is recognised based on the period that is being invoiced.

Interest revenue is recognised when it becomes receivable on a proportional basis taking into account the interest rates applicable to the financial assets.

Dividend revenue is recognised when the right to receive a dividend has been established.

Commission revenue is recognised based on the period that it is earned.

All revenue is stated net of the amount of goods and services tax (GST).

(C) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and any accumulated impairment losses.

Property

Property is measured on the cost basis.

Plant and equipment

Plant and equipment is measured on the cost basis.

(d) Income tax

Only non-member income of the association is assessable for tax, as member income is excluded under the principle of mutuality.

Deferred tax assets and liabilities are recognised for all temporary differences, between carrying amounts of assets and liabilities for financial reporting purposes and their respective tax bases, at the tax rates expected to apply when the assets are recovered or liabilities settled. Exceptions are made for certain temporary differences arising on initial recognition of an asset or a liability if they arose in a transaction, other than a business combination, that at the time of the transaction did not affect either accounting profit or taxable profit.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Current and deferred tax balances attributable to amounts recognised directly in equity are also recognised directly in equity.

(e) Employee benefits

Liabilities arising in respect of wages and salaries and any other employee benefits expected to be settled within twelve months of the reporting date are measured at their nominal amounts based on remuneration rates which are expected to be paid when the liability is settled. All other employee benefit liabilities are measured at the present value of the estimated future cash outflow to be made in respect of services provided by employees up to the reporting date.

Contributions made by the association to an employee superannuation fund are recognised as a liability, after deducting any contributions already paid as an expense as they become payable. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payment is available.

(f) Impairment

Assets with an indefinite useful life are not amortised but are tested annually for impairment in accordance with AASB 136. Assets subject to annual depreciation or amortisation are reviewed for impairment whenever events or circumstances arise that indicate that the carrying amount of the asset may be impaired. An impairment loss is recognised where the carrying amount of the asset exceeds its recoverable amount. The recoverable amount of an asset is defined as the higher of its fair value less costs to sell and value in use.

(g) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand and at banks, short-term deposits with an original maturity of three months or less held at call with financial institutions and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the statement of financial position.

(h) Goods and Services Tax (GST)

Deferred tax assets and liabilities are recognised for all temporary differences, between carrying amounts of assets and liabilities for financial reporting purposes and their respective tax bases, at the tax rates expected to apply when the assets are recovered or liabilities settled. Exceptions are made for certain temporary differences arising on initial recognition of an asset or a liability if they arose in a transaction, other than a business combination, that at the time of the transaction did not affect either accounting profit or taxable profit.

Cash flows are presented in the statement of cashflows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

(i) Comparatives

Where necessary, comparative information has been reclassified and repositioned for consistency with current year disclosures.

(j) Critical Accounting Estimates and Judgements

Estimates and judgements are based on past performance and management's expectation for the future. There are no critical estimates and judgements used in the financial report.

(n) Accounting Standards Issued But Not Yet Effective

Certain new accounting standards and interpretations have been published that are not mandatory for 30 June 2014 reporting periods. The associations assessment is that these new standards and interpretations will have no material impact on the financial reporting obligations of the company.
